Some of the Institute's achievements include the first appellate court decision nationally to recognize predatory lending as a civil rights violation; the establishment of a program that prepares recent urban high school graduates to enter the construction trade unions (a program New Jersey has committed up to \$30 million to replicate statewide); a unanimous state Supreme Court ruling precluding juvenile offenders from being locked up for non-criminal offenses such as violation of curfews; the first committed effort in the state to bring together government, business, scholars and non-profits to focus on the challenges of adult and juvenile prisoner reentry; and the establishment of a transitional employment program for ex-offenders. While the Institute has a statewide perspective and is engaged in activities with national implications, many of its efforts begin in Newark, where the Institute is based.
